However, the intellectual and industrial rights of the designs belong to our organization, and the project files are shared on the condition that they are not shared with third parties in any way and not used in any other project. If the documents of the projects are shared with third parties or used in another project, legal action will be initiated within the framework of the relevant legal legislation. 3	Design Dossier	ITB 22.1 & ITB 25.1	Due to the fact that the tender offer type is not unit-priced, and the project files cannot be provided in DWG format, we kindly request an extension of the tender deadline to ensure a more accurate and comprehensive pricing study. Considering the extensive scope of the project, additional time is required for a thorough evaluation. Therefore, we respectfully request an extension of the tender period. 4	-	-	A WWTP project includes construction and 5-year operation phase. Additionally, the operation process has been considered part of the construction work, and the Temporary Acceptance of the construction work was done at the end of the operation period. Furthermore, the final acceptance date of the work was set based on 12 months of warranty following the temporary acceptance. Therefore, the Temporary Acceptance of the Construction Works and the Operation Temporary Acceptance have been considered on the same date for the project's completion and uploaded to EKAP. Taking the above matters into account, we believe that the temporary acceptance date validated by the Authority (ISKI) meets the qualification criteria for the "Construction of Ankara Central (İvedik) Water Treatment Plant Capacity Increase" tender.
